

# Senator Bill Ferguson's 2026-2027 Scholarship Application

*Please read the following guidelines prior to filling out the application to ensure that you qualify. Once you have completed the application, please mail or email it with the rest of the required materials.*

## Who may apply:

- You and your parent or legal guardian (if you are a dependent student) must be Maryland residents living in the 46<sup>th</sup> legislative district. **Scholarships will not be granted to students outside of the 46<sup>th</sup> District.** If you need to verify your residence in the 46<sup>th</sup> District, please visit <http://mgaleg.maryland.gov/mgawebsite/Members/District> or call (410) 946-5200.
- Current high school seniors, full-time or part-time degree seeking undergraduate and graduate students, and students attending private career schools. Audited courses cannot be used to reach the minimum credit hours required for full-time or part-time status.
- You may use this scholarship at an out-of-state school if your major is not available at a Maryland school, or if you require special accommodations not offered at a Maryland school. Office of Student Financial Assistance (OFSA) must verify that your major is unique. **More information can be found at [www.mhec.maryland.gov](http://www.mhec.maryland.gov)**

**How to apply:** Complete and file the Free Application for Federal Student Aid (FAFSA) in addition to Senator Bill Ferguson's Scholarship Application. If you are a qualifying child of undocumented immigrants and are eligible for in state tuition, you may apply using the Maryland State Financial Aid Application (MSFAA) in addition to Senator Bill Ferguson's Scholarship Application. **When to apply:** Complete and file the **FAFSA or MSFAA by the Maryland deadline of March 1, 2026.** Include a copy of your FAFSA Submission Summary (FAFSA) or verification of a completed MSFAA with your completed application, which must be **submitted to our office by midnight on May 1, 2026.**

**Awards Granted:** Criteria for selection are based on academic achievement, financial need, and commitment to higher education. The minimum annual award is \$500, and the maximum award is \$2,500. Most scholarship awards are granted for four years for full time college students (or eight years for part-time students), without the need to reapply (see below). You may hold the Senatorial Scholarship along with all State awards. The total dollar amount of all State awards may not exceed your cost of attendance as determined by your school's financial aid office or \$19,000, whichever is less. Funds may not be available to award all eligible students.

**Renewing an Award:** If you have received a renewable award from Senator Bill Ferguson during a previous academic year, your award will be renewed automatically as long as you maintain satisfactory academic progress at the college you attend. Full-time students may receive a Senatorial Scholarship for a total of four years. Part-time students may receive a Senatorial Scholarship for a total of eight years.
